



One-Year Puppy Health Guarantee

1. Health Guarantee Duration

The breeder guarantees the puppy is in good health at the time of sale and is free from *life-threatening congenital or hereditary defects* for a period of **one (1) year** from the date of birth.

2. Veterinary Examination Requirement

The buyer agrees to have the puppy examined by a licensed veterinarian **within 72 hours** of delivery or pickup. Failure to do so voids this health guarantee.

The buyer commits to completing the vaccinations at 12 weeks and 16 weeks. The buyer will make sure that the Rabies shot will be given **separately** from regular vaccinations as it can overload a growing puppy's immune system. Failure to do so voids this health guarantee.

The buyer agrees to spay/neuter the puppy between 6 and 9 months and provide veterinary proof. Failure to provide proof of spay/neuter will void health guarantee and buyer will be charged an additional \$3,000.00

3. Covered Conditions

This guarantee **only covers** congenital or hereditary defects that result in:

- Death of the puppy
- The veterinarian's recommendation of euthanasia due to poor quality of life.

Conditions such as worms, parasites, minor illnesses, coccidia, giardia, or treatable infections are common in puppies and **are not covered**.

4. Exclusions (Not Covered)

This guarantee does **not** cover:

- Normal veterinary costs (vaccinations, check-ups)
- Conditions caused by neglect, abuse, injury, or lack of proper care
- Conditions resulting from over-exercising, poor nutrition, or improper environment
- Breed-specific conditions not deemed life-threatening (e.g., hip dysplasia in large breeds not confirmed by OFA/PennHIP before 1 year of age)
- Guarantee is non-transferable to another owner other than said buyer.

5. Claim Process

If a covered defect is diagnosed:

Buyer must notify the breeder within **48 hours** of diagnosis

Diagnosis must be confirmed by **two licensed veterinarians**, one of whom is chosen by the breeder. Breeder reserves the right to request veterinary records and conduct their own evaluation

6. Remedy

If a covered defect is confirmed:

The breeder will **replace the puppy** with one of equal value from the next available litter

No cash refunds will be given

Shipping or transportation costs are the **responsibility of the buyer**

7. Return Policy

If the buyer chooses to return the puppy for any reason unrelated to a covered health issue, no refund or replacement is guaranteed, and return acceptance is at the sole discretion of the breeder. There are no refunds for said **Puppy** in the case of allergies to said **Puppy**, or for any other reason not stated in this contract.

8. Limitation of Liability

The breeder's total liability under this agreement shall not exceed the purchase price of the puppy. Under no circumstances shall the breeder be liable for any veterinary bills incurred by the buyer after the sale. Said **Breeder** does not assume any liability for any injury to said puppy after delivery. Said **Breeder** shall not be held responsible for any acts of said **Puppy**.

9. Entire Agreement

This agreement constitutes the entire understanding between the buyer and breeder. No other warranties or promises, written or verbal, are valid unless stated in writing and signed by both parties.

I the buyer agree to the above stated terms of health guarantee and hereby promise to be a responsible pet owner. I the buyer understand that a owning a puppy/dog is a financial and physical and time consuming commitment. I understand that proper food, veterinary care, grooming, and obedience training can be costly and I am able to meet these requirements. By signing below, I acknowledge that I have completely read this guarantee and confirm my commitment to purchase/provide for said Bernedoodle puppy.

I the Breeder reserve the right to cancel the sale of said Puppy at any time if said **Buyer** is in breach of contract or verbal agreements or for any reason based on said Breeder's discretion. Said Buyer will be notified in writing via email and/or post mail of the cancellation of sale.
